November Coalition Meeting



Our coalition had our first in-person meeting November 2! We had 31 members attend a great and productive meeting! Highlights from the meeting include:

- a review of the VIBRANT MOMS (VM) project; an introduction of the Consolidated Framework for Implement Framework (CFIR)
- overview of the data collection methods and plan
- discussion on governance of the coalition—with the decision for all attendees to vote during meetings and the ability to invite additional members without the need for approval
- selected our VM logo
- refined the focus group questions via small group discussions
- and door prizes!



Hospital Data Update

Our team is diligently preparing to capture the prevalence of preeclampsia, diabetes, and other adverse health conditions among pregnant women in Deaf Smith, Gray, Parmer, Potter, Randall and Swisher counties to quantify the medical needs of the mothers in our community and to meet objective 1.c. of the IMPROVE-CIP grant. We have identified a new source for data that will permit comprehensive visualization of all delivering mothers in our priority population.

The Texas Hospital Inpatient Discharge Public Use Data File (referred to as Texas PUDF) is available through the Texas Health Care Information Council (THCIC) and collects data for discharges from all state licensed hospitals except those that meet exemption criteria. The dataset is available for free to public universities, and we have submitted the data use agreement through the appropriate channels to obtain the data. The last step before analysis is Institutional Review Board (IRB) approval. Though this is a de-identified, public use file, we will take the extra steps to submit to the TTUHSC IRB for enhanced care of our human subjects. We look forward to updating you next month with some preliminary data!
